- Be able to provide satisfactory documentation that they are enrolled in a degree or trades program to which there is a cost to attend.
- Be able to provide examples of how they embrace the People Helping People mission in their personal lives, through volunteerism, community-centered employment, and/or school activities.

Stay One Step Ahead of Fraud with IDCheck: Coming Soon for Shared Branch Members

What is Shared Branching?

- Secure, in-person transactions at any participating branch.
- Wide variety of transactions including loan payments, cashier's checks*, deposits, withdrawals, transfers, account inquiries, and much more.
- Locator services via mobile app, online and telephone.

Because Northwestern Mutual Credit Union is part of the shared branch network, our members can access their funds in person at any credit union that is also part of the network. This includes **over 5,600 shared branch locations and 30,000 CO-OP ATMs across the US**, meaning our members can access their money at more locations than most banks!

Northwestern Mutual understands it's crucial to help protect you from account takeover fraud. That's why we want to inform you about a new ID proofing measure for in-person visits to Shared Branch locations. This new fraud prevention measure allows us to make certain it is **YOU** trying to access your account, not an imposter.

How IDCheck Works

If you bank at a Shared Branch location, a teller can now identify and authenticate members with out-of-state IDs in the branch through a QR code and one-time passcode multi-factor authentication verification. Most financial institutions will be using this additional layer of authentication for cash withdrawals using out-of-state IDs.

- 1) Scan the QR code located in the branch of visit verify.coop.org.
- 2) Select your credit union's name from a drop-down list.
- 3) Enter your member number and the last four digits of your social security number.
- 4) Upload a photo of your ID.
- 5) Take a selfie.
